Small amounts of text may be used, but only where the source of the material quoted is clearly acknowledged and the text is inserted in quotation mark. Regarding ethics of scientific publishing, the journal will follow the recommendations of the Committee on Publication Ethics/COPE (<http://publicationethics.org>) and International Committee of Medical Journal Editors/ICMJE (<http://www.icmje.org>). If the journal finds the potential or suspicion of misconduct, the COPE guidelines will be exactly followed. *The journal will not consider any manuscript which is ethically unacceptable.* The journal reserves the rights to make further changes in language, grammar, style, presentation, etc. to suit the journal's requirements. Shortly before publication of the article, the journal may do further scientific revisions according to final comments of the editorial board.

3. Final approval of the version to be published; AND
4. Agreement to be accountable for all aspects of the work in ensuring that questions related to the accuracy or integrity of any part of the work are appropriately investigated and resolved.
